**DECLARATION OF ROBERT S. BANKS, JR. IN SUPPORT OF MOTION FOR
ATTORNEY FEES AND EXPENSES**

I, Robert S. Banks, Jr. make the following statement under penalty of perjury.

1. I have been a member of the Oregon State Bar since 1982. I am an attorney at Samuels Yoelin Kantor LLP, and acted as Oregon counsel for Plaintiff Ira Nathan from the inception of the case to June 17, 2016. I have personal knowledge of the matters set forth in this declaration. If called to testify in court under oath, I would testify to the facts set forth in this declaration.

A. Retention Agreement And Contingent Nature of Representation

2. My firm represented Mr. Nathan on a wholly contingent basis. True and accurate copies of Plaintiffs' retention agreements are attached to the Declarations of Jason Leviton and Peter Andrews submitted herewith. To date, my firm has not yet been paid anything for services rendered in connection with the above-captioned action.

B. Work Performed

1. My firm acted as Oregon counsel to Plaintiff Nathan from the inception of the action until June 2016. In this role and during that time, we provided guidance and local expertise about Oregon practices and procedures. We attended hearings and assisted in reviewing and revising all documents filed with the Court both for substance and compliance with Oregon practices and procedure. At the Court’s request, I also prepared a declaration responding to the Court’s questions regarding compliance with ORCP 32 H in July, 2017.

C. Time And Expenses

3. My firm’s timekeepers spent 120.25 hours litigating the above-captioned case from its inception to the date of the Stipulation of Settlement.

4. The total lodestar for my firm is \$24,583.25. The hourly rates for the attorneys and professional support staff in my firm shown below are the reasonable and customary rates charged for each individual timekeeper. My firm’s lodestar figures are based upon the firm’s current billing rates. A breakdown of the lodestar is as follows

5. The hourly charges listed above do not include charges for expenses. Expense items are billed separately and such charges are not duplicated in my firm’s billing rates. The firm has incurred a total of \$1,846.17 in unreimbursed expenses in connection with the prosecution of the action from its inception through the date of this Declaration. These expenses

are of the type routinely charged to the firm's hourly paying clients and were necessarily incurred in prosecution of the action. The expenses pertaining to this case are reflected in the books and records of my firm and consist of the following:
